1. Foreword

Since its foundation in 2009 and the legal incorporation in 2012, the Network of European LGBTIQ* Families Associations (NELFA) has been growing year after year. Our movement is gaining further strength and momentum, even if the political climate changes in many countries and the (far-right) populism is getting stronger. Since our last AGM in Barcelona, in March 2016, rainbow families all around the world have faced some painful setbacks. But: not only! Gradually, there is solid and reassuring progress, at least in the European Union - through quality juridical decisions, positive survey results and an increasing political backing. In the last twelve months, NELFA worked tirelessly to improve the living conditions of children and their lesbian, gay, bisexual, trans, intersex or queer parents. This report points out our efforts for more legal recognition, protection, equal treatment and acceptance – with pride, courage, optimism and contagious joy.

We had a couple of highlights of our work and progress in 2016:

- the 5th International Family Equality Day, IFED 2016 (motto: ‘Families Without Borders’), which was celebrated in 74 cities in 36 countries. For the first time, Ecuador, Norway, Russia, South Africa, Sweden and Venezuela joined IFED
- The AllOfUs-event (‘Mobilising for Rainbow Families’) in the European Parliament with testimonials of NELFA Board members and a corresponding declaration, signed by four political parties (S&D, ALDE, The Greens/EFA, GUE/NGL)
- NELFA’s participation in the Eurochild Conference in Brussels (“Children’s Rights Matter”), represented by 16-year-old Darragh Tibbs from Northern Ireland
- NELFA’s workshop ‘Against the backlash: Building joint strategies for LGBTIQ* families activism’ during the ILGA-Europe Conference in Nicosia/Cyprus
- NELFA’s new participatory status with the Council of Europe and the opportunity to provide rainbow family experiences and examples of good practice at the roundtable session of the European Governmental LGBTI Focal Points Network
- NELFA’s successful Erasmus+ application (project: ‘Adequate and equal legal protection for rainbow families’) and the ability for Board members and several volunteers to take part in professional training courses and job-shadowings
- NELFA’s International Conference “Rainbow Families in Europe. Same love, different status” in Naples/Italy, organised in particular by NELFA Board member Giuseppina La Delfa, with the help of Famiglie Arcobaleno.

The report below contains an overview of the activities conducted by NELFA between the AGM in Barcelona (March 2016) and the AGM to be held in Naples (25 March 2017).



2. Administration

2.1. Board

The current Board consists of the following 15 persons (from 10 different countries):

Liz Corder from Rainbow Families Brighton&Hove (UK), resigned in May 2016. In addition, Luís Amorim, Angelo Berbotto, Lisa Green, Rita Marascalchi, Krisztian Rozsa, Kathryn Clarke and Anne Rudolph have announced to step down in Naples (March 2017).

2.2. Board meetings

There were several smaller meetings with at least three Board members in Brussels (Apr and June 2016), Nicosia (Oct 2016), Barcelona (Dec 2016) and Copenhagen (Feb 2017).



2.3. Membership

By the end of February 2017, the association had 29 full member organisations, covering 19 European countries, and 3 supporting members. (Note: the member status of “Familyship” [Germany] was refused during the AGM in Barcelona because of their business activities, but the exclusion has not been executed, yet.

In 2016, NELFA welcomed two new full members:

Son Nuestros Hijos (Spain) and LGBT Denmark (Denmark).

2.4. Finances

At present, NELFA has more money than usual, due to high funds (EU Erasmus+ [30,815 EUR] and OSIFE (Open Society Initiative For Europe) [25,000 USD]). However, the prevailing part of the money is intended to specific projects. Normally, NELFA’s budget derives from membership fees and donations, Board members bear a large part of the costs (i.e. flight tickets) on their own.

2.5. Change of name

NELFA has taken initial steps to include families of queer people in its community by adding a “Q” to its name and changing it into “Network of European LGBTIQ* Families Associations”. The asterisk reinforces NELFA’s openness to all family constellations beyond LGBTIQ (Lesbian, Gay, Bisexual, Transgender, Intersex and Queer).

NELFA bylaws have been duly amended in January 2017.

3. Communication

3.1. Mailing lists

NELFA used its membership network and mailing lists to share and disseminate information, with special focus on relevant European developments, as well as to express support and mobilise resources on a number of issues, including:

- The urgent request for testimonials in connection with a UN Panel Discussion on "Stories for a UN Parent: Equality for all Children" in Geneva (March 2016)



- The announcement of the recent re-design of the IFED website (March 2016)
- The sharing of an empowering video from a local event of “Rainbow Families Brighton&Hove” and the request to send similar clips (March 2016)
- The dissemination of information about the IFED-IDAHOT cooperation in 2017 and the contributions of a Russian initiative for IFED (March/April 2016)
- The sharing of news and scientific material (i.e. of the Dutch member “Meer Dan Gewenst”) (April 2016) and a call to react from Lithuania (April 2016)
- Further IFED news: for example the start of the social campaign (May 2016)
- The request of Russian allies for rainbow family activities in Europe (May 2016)
- The (successful) application of the Erasmus+ project “Adequate and equal legal protection for rainbow families and the necessary follow-ups [in order to provide information about training courses etc.] (May, September and November 2016)
- The (successful) application for NELFA’s participatory status with the Council of Europe in Strasbourg as International NGO (May 2016)
- The reminder for contributions to the IFED Annual Report (July 2016)
- The request from ILGA-Europe about LGBT-prisoners in Belgium (July 2016)
- The exchange of advice in order to respond the handling of the Finnish immigration authority with a Russian rainbow family (August 2016)

3.2. Facebook

NELFA’s current Facebook activity is quite regular. The number of “likes” increased from 1,449 (March 2016) to 1,807 (16 Feb 2017) [1,837 (24 March)]. NELFA published (in the above-mentioned period) 561 posts (378 links, 123 pics, 24 videos and 8 unspecified posts).

The biggest part of our fans come from Spain, Italy and Germany (followed by people from Portugal, France, Finland, Belgium, UK, Greece and the USA). The Facebook statistics found that 56 % are female supporters and 41 % are male supporters, usually between 25 and 54 years old. Especially, Board members Björn Sieverding, Maria von Känel and Caroline Ausserer keep the page regularly updated. So far, Luís Amorim is the responsible administrator. Some more FB editors make sporadic contributions: Rita Marascalchi, Jelle Martens, Katy Pallas Pico, Jesús Santos Homobono, Chatty Ecoffey, Fabrizio Paoletti, Angelo Berbotto and Juha Jämsä.



3.3. Website

The (formally hacked and then meagerly re-installed) NELFA website www.nelfa.org will be relaunched (very soon) with the tremendous support and expertise of graphic designer Francesca Silvestri. The media team was and is responsible for further contributions. In the following months, the website should be revamped; the contents are to be extended.

The IFED website is also in process of being improved both in its structure and design to make it more professional and flexible, allowing for inputs by national coordinators. Different items from the cooperation with IDAHOT are integrated, such as a list with films about LGBTIQ* and families.

3.4. Twitter

NELFA is also present on twitter (@NELFA_LGBT). At the moment (24 March 2017), we have 295 followers and we are following 127 twitter users. Within the last year, NELFA posted 124 tweets and retweeted 114 messages (until Feb 2017). The main editor is Maria von Känel. We tweet in particular when participating at events and gained several new followers e.g. after the ILGA-Europe conference.

3.5. Press releases

The NELFA media team published in total 32 press releases within the last year. Each document was (usually) sent out to our members and a wide range of LGBTIQ* medias and supporters. 3.6. Newsletter

The number of subscribers increased steadily from 140 to 145 to 167. Currently, we count 172 subscribers and we expect a moderate rise of demand in the upcoming months. The media team is working on a strategy how to disseminate it the best way.

4. Advocacy and Lobbying

4.1. European Meeting of Rainbow Families

After the European Meetings of LGBTIQ* Families in France (2010), Spain (2012), Germany (2014) and Portugal (2015), there was – unfortunately - no new meeting organised in 2016. FLG (Spain) had examined to possibility, but decided against it. We would like to encourage full members to take into account to organise one in 2018.

4.2. International Family Equality Day (IFED)

In 2016, IFED was celebrated in 36 countries (2015: 32) and 74 cities (2015: 67) worldwide. The motto was "Families Without Borders" and six more countries joined the IFED family: Ecuador, Norway, Russia, South Africa, Sweden and Venezuela. In May 2017, both the International Family Equality Day (IFED, May 7) and the International Day Against Homophobia, Transphobia and Biphobia (IDAHOT, May 17) invite advocates for LGBTIQ* equality, their friends and allies to take action in support of diverse and safe families. The motto of IFED 2017 is "Love Makes A Family". In 2016, NELFA received funding from OSIFE amounting of 25,000 USD, for the IFED coordination and other IFED expenses.

- NELFA took part in the roundtable session at the Council of Europe, where the European Governmental LGBTI Focal Points Network examined the situation of children in rainbow families, and NELFA's President gave an opening speech
- NELFA took part in the "Rainbow Philanthropy conference on sexual and gender self determination of children and youth in alternative care in the Global South and East". Board member Caroline Ausserer led the workshop "It's what is normal for me - About LGBTIQ* children from a family perspective"
- NELFA Board member Dominique Boren attended a seminar of the PES group (Party of European Socialists) in the Committee of the Regions in Brussels. Its motto: "I am what I am: promoting the rights LGBTI in the EU"

December 2016:

- NELFA volunteers from Finland (Marita Karvinen, Paula Myöhänen, Sanna Nevala and Marjukka Irni) attended the Erasmus training course "Teaching and training for LGBT" from our partner "In Dialogue" in Copenhagen

4.4. Eurochild Conference (Brussels, 5-7 July 2016)

NELFA was represented at the 2016 bi-annual conference of Eurochild by Darragh Tibbs (aged 16), his two mothers and younger brother, from Northern Ireland. The theme was 'Children's Rights Matter'. It was the first time Eurochild integrated young people's voices in the running of their bi-annual conference. Darragh's participation was part of NELFA's aim to bring the voice of children raised by rainbow families into mainstream events where children's rights are discussed. Eurochild represents more than 190 organisations and individuals from 33 countries in Europe, and its main aim is to advocate for children's rights and well-being to be at the heart of governments' policymaking.

5. Capacity building

As already mentioned, NELFA received funding for its project "Adequate and equal legal protection for rainbow families", within the framework of the Erasmus+ programme. Board members and volunteers have been granted to attend 16 training courses (in corporation with the Dutch/Danish consultancy service provider "In Dialogue") and 6 job-shadowings (with organisations like LSVD in Berlin and Stonewall in London).

The 22 "mobilities" aim at strengthening NELFA, especially towards its educational activities. The participants train themselves in leadership skills, teaching and consulting skills, as well as guidance skills. In February 2017, NELFA cooperated again with "In Dialogue" to send out a new application to the Erasmus+ Agency in Brussels. The decision on the project "Chances and challenges for rainbow families" is expected in June.

NELFA itself provided several workshops on the topic "rainbow families", i.e. during the ILGA-Europe Annual Conference in Nicosia (October 2016, see above). Board members shared their experiences on various occasions (i.e. in Brussels, Moscow, Strasbourg etc.).



6. Co-operation with external partners

6.1. COFACE

NELFA has applied for membership of COFACE-Families Europe (the Confederation of Families Organisations in the EU, a network promoting the well-being, health and security of all families). COFACE recently offered a supporting membership.

6.2. European Union

NELFA continued to work closely with the European Parliament Intergroup on LGBTI Rights and with ILGA-Europe. Furthermore, Board members provided insight into their private life as LGBTIQ* parents with children during the AllofUS-event in the European Parliament.

NELFA and 176 other organisations subscribed a common statement for the EU Bratislava Summit in September 2016. The Network supports “A new Europe for people, planet and prosperity for all”. The aim of the statement is to take action, to shape an open, accepting society for us and our children, where fundamental rights are protected and equality and inclusion guaranteed.

6.3. Council of Europe

In September 2016, NELFA has been granted participatory status with the Council of Europe (CoE). Since 1952, the human rights organisation has had working relationships with international non-governmental organisations (INGOs). Today, the status is held by some 320 INGOs. The status increases NELFA's ability to support family diversity in all 47 member states of the CoE. Our Network has now the opportunity to contribute to emancipate civil society and reinforce the participation in decision-making processes, as well as building a society based on equality, justice and human rights.

In November 2016, NELFA was invited to the roundtable session at the Council of Europe. The European Governmental LGBTI Focal Points Network examined the situation of children in rainbow families, and President Maria von Känel had the opportunity to provide day-to-day experiences and to share examples of good practice.

6.4. Others

The European Rainbow Cities published information about the IFED 2016 Annual Report in their November newsletter. Several Rainbow Cities are actively involved in organising IFED 2017 events, together with local rainbow family associations.

NELFA shared experiences with some scientific researchers for the meanwhile completed FamiliesAndSocieties Conference, coordinated by Stockholm University. The main topic was the question, what families will look like in the future and if the existing social and



family policies are compatible with changes in family patterns. Some (positive) studies concerning rainbow families and the development of legislation were already published

7. Publications

NELFA and its partners published the recent **IFED Annual Report** in September 2016, printed 1,000 copies and posted the 80-page document on the IFED website.

Once again, the Report has been used as a practical toolkit to address lobbying strategies and as a means to strengthen the visibility of rainbow families around the world. Another aim is to form alliances with representatives from public services, institutions and politicians in order to foster the recognition of all families.

The IFED 2016 Annual Report featured contributions from activists all over the world and forewords from Charles Radcliffe, U.N. official at the OHCHR, and Tanya Plibersek, Australian Member of Parliament and Deputy Leader of the Opposition.

NELFA also updated, printed its **leaflet**, which is to be found on the NELFA website.
